Official YOGi Cycling Club Constitution & Rules:

YOGi Cycling has been structured to be a lean & transparent organisation; guidelines and rules have been kept to a bare minimum and are in place to ensure that all members understand fully what YOGi Cycling is before and after they join. When you join YOGi Cycling you must agree to be bound by the rules and try to follow the guidelines.

1. The name of the organisation shall be YOGi Cycling or YOGi.
2. YOGi Cycling will be not-for-profit and all monies generated from membership fees and sponsorships will be used for affiliations, administration, promotion, expenses and club events.
3. YOGi Cycling is directed by the committee.
4. The main sponsor shall be as decided by the YOGi Cycling committee – all sponsorship arrangements require a formal signed agreement in accordance with British Cycling requirements.
5. Other sponsors shall, from time to time, be associated with YOGi Cycling, at the discretion of the YOGi Cycling committee, in consultation with the existing main sponsor.
6. Membership of YOGi Cycling is open to any individual, subject to the approval of the YOGi Cycling committee.
7. The membership subscription fee will be £10 per annum.
8. Any member who has not paid their membership subscription by expiry date will be deemed to have left YOGi Cycling and their membership will be cancelled.
9. The committee reserve the right to terminate membership.
10. Any member who leaves YOGi Cycling is not entitled to a refund of all or part of their membership.
